- E. Reports by Council Members and Officers:

- 2. Councilmember Gonzales—Planning and Zoning—. Councilmember Gonzales mentioned you have received all of your documentation for P&Z that Mr. Wallace and Clerk Mitchell provided for you. W will discuss them later in the meeting.
- 3. Councilmember Wallace Parks and Recreation-. Councilmember Wallace reported we had our Expo on Saturday. It was a good turnout but could always be better. We had a raffle every 15 minutes. Councilmember Wallace would like to thank Councilmember Hirshberg for helping set up and Clerk Mitchell for doing the raffle and Mayor Taylor for helping with the raffle, cleaning afterwards and spending the day.
- 4. *Councilmember Johnson Public Safety*-Councilmember Johnson was absent. Assistant Chief Police Thies answered Mayor Pro Tem Perry's question as to why all the police were at city hall. Assistant Chief Thies stated they were having an operation going on. They were staging here in Huachuca City.
- 5. *Mayor Pro Tem Perry Public Works* Mayor Pro Tem Perry stated on Gonzales the fire hydrant has been fixed. PW is mowing a lot of grass. The land fill we need to order another tarp sometime soon. Mayor Pro Tem stated that we don't cover every day with dirt they use the tarps.
- 6. *Councilmember Hirshberg– Finance-*. Councilmember Hirshberg said we have our payment approval in the amount of \$66,223.46.
- 7. *Mayor Taylor*-Mayor Taylor would like to have the Biker Group Nomadens step up and state what they are doing. They said they are having a Christmas in July but have changed it to October for several reasons. This fundraiser will be on October 25, 2015 and they would like to invite the council and all the citizens to attend. This is the 27th year of fundraising for the children. Also Mayor Taylor said our animal shelter has two sets of puppies ready for adoption.
